morning on the Wednesday in order to make time for a live argued moot which will have a panel of at least three 'judges'. These will not only represent common and civil law but will also include ADR and will reflect different attitudes prevalent in various territories.

We appear, from the accepted invitations to date, to be attracting an extremely high calibre of Speaker and hope to have a delicate blend of 'old friends' and 'new blood' As a result of the Preliminary Announcement we have been asked to reserve over a third of the total places available and the requests are on a world-wide basis. What is encouraging is that the applications seem roughly split in half between those who have been delegates to previous Colloquia and those new to us. The Government have once again invited us to a formal Reception but have, unlike previous years, decided to "Welcome to London" the guests by holding it on the first night. We are also introducing just enough change to the remainder of the social programme for delegates to be able to realise that it is a Colloquium, but without it being just like last time.

The Theme of the Colloquium is "THE MAKING AND BREAKING OF INSURANCE CONTRACTS". With the many changes taking place not just here but abroad and the alterations that the Single Market are likely to introduce, this should prove an opportunity to be prepared for the tomorrow today!

We have invited AIDA Presidential Council and Working parties to meet in London on the Monday and Tuesday the 10th and 11th July and hope that they will be accepting our invitation.

Booking forms should be distributed in October giving more details.
